Our present home is situated in Ayanavaram Chennai and this building was constructed in



the year 2000. The Total surface of the area is 975 Sq. Ft. We pay huge amount of Rent Rs. 37,000 for every month, which is a major expense we meet every time. As our House owner suddenly said that, she is going to sell this Home (Presently, which is functioning as a children's home) due to financial constraints. A Consideration part of our monthly Expenses consists of the rent for the building in which the children home is located. At the same time we are dependent on the good will of the house owner who could demand the building back in a short time

Greater Love Children Home is planning to buy need land for orphanage children in order to build a new orphanage making it independent and ensuring the continuity of our mission. This way we can extend our assistance providing a better place to live for many more neglected children. The plot of land and a new building will cost around Rs.1, 06, 00,000. We are trying to raise local funds up to Rs.6, 00,000. The cost of the required plot of land for a new orphanage that will change our children's lives forever!
